Our thoughts and prayers go out to all the families that lost life and property during this disaster. This also includes our family of rescue squads and fire departments that also sustained losses. I was proud to see that in this time of need, not only did the citizens of Alabama, but people from all over this country reached out to help their neighbors whether it be a few miles or a few hundred miles away. Things like this also bring out the bad in people but it seems that the good outweighed the bad this time. Many of the AARS squads are still working to help take care of their communities at this time. If your squad is need of assistance in this ongoing effort let one of your AARS officers know what kind of help you need. We will do everything we can to help. I would like to personally thank the squads that came to Morgan County to assist in the recovery of our drowning victim. He was recovered on Easter Sunday. I am very proud of our family of AARS members that gave up their Easter weekend with their families to help his family have closure. It just goes to show what kind of dedicated and caring people we have in our AARS family. On Memorial Day weekend the Huntsville Cave Rescue Unit was called to assist Hamilton County Rescue Squad in Tennessee to rescue a caver from Sinking Cove Cave. The caver fell about 20 feet on the seventh drop in the cave. Injuries at the time were thought to be a broken arm, broken leg, and a broken pelvis, which later turned out to be a broken back. It took 29 hours from the time he fell, till he was removed from the cave and flown to the hospital. We documented over 100 people on scene and at one time we had 64 rescuers in the cave. The HCRU had 27 people respond. As it turned out the injured caver just happened to be one of our own members and a dear friend of mine. He is out of the hospital and recovering well. These bad ones don't happen often but when they do it takes a lot of skill and knowledge to handle it. This just goes to show how important continued training is. Remember if you don't use it you lose it. Speaking of training the conference will be here before you know it. We need input on what type of training you would like to have there. Please give us your ideas. Always remember the AARS is your organization and it is what you make it. Get involved and make a difference. Thank you all.



The first three weeks, after the April tornadoes, we served and delivered up to 1800 meals a day and had over 9000 man hours. We were one of the few to have continuous power and hot water for showers due to having a generator in place. We have been assisting the community however needed since the tornado. We are still handing out ice, water and Gatorade to those who are working out in this heat. The people in the community are starting to get trailers in or rebuilding so we have also been assisting them with the help of our community action service, we have small appliances, bedding, furniture, and food we have been handing out. We are now in the process of our annual fireworks sale. On July the 16th we are planning a volunteer cookout, for all the wonderful people who gave up their time to help us out during the tornado. On July 30th we have rescheduled our annual fish that we postponed in May due to the weather. In August our squad helps host the quarterly meeting in Rainsville. Soon summer will be over and kids will be back in school, always keep their safety in mind.
