Amazing Rescue at High Falls Park By Tony Taylor


High Falls Park is located on Town Creek between Geraldine and Grove Oak. The 35 ft. waterfall is a popular attraction for adults and teenagers who travel great distances to see the beautiful scenery and to jump off the point rock. The falls span some 300 ft. across at times. It is truly a beautiful place but also a very dangerous place. Visitors are advised to avoid the rough waters below the falls but some still choose to "take the plunge."

On the afternoon of Monday, April 30, Geraldine Rescue was paged to High Falls Park to rescue a young man who became ill while swimming with friends. Apparently the teenager suffered an asthma attack or other medical problem during or shortly after his plunge from the 35 ft. waterfall. The young man was pulled from the water by a friend but was in serious condition. The two friends remained on a large rock in an area below the waterfall waiting for help to arrive.

One of the first responders was Geraldine Rescue Squad member John Smothers. Upon arriving at the scene, he was alerted that the young man had stopped breathing. Without hesitation, John climbed down the rock bluff at the waterfall and swam across the creek to a ledge at the base of the large rock formation called the arch rock to help the young man. He found that the young man was breathing but was in serious condition. John stayed with the teenager until Fischer Rescue arrived and used their high-angle rope rescue system to get the young man safely from the area below the waterfall to a rock bed above the waterfall where a medical helicopter was waiting to take him to the hospital.

Geraldine Rescue and Fischer Rescue have worked together numerous times at High Falls. On this particular rescue, a rope system, along with a second safety rope, was set up. Fischer placed flotation devices on a specialized basket and floated the teenager across the creek to the point at the base of the rock wall. Fischer and Geraldine squads along with representatives from the Alabama State Troopers, DeKalb Ambulance Service, DeKalb County Sheriff's Office, and Geraldine Police Department worked together to lift the teen from the bottom of the 35 ft. waterfall to the top. It took about 45 minutes from the time they got him in the basket, across the water and to the top of the rock wall.

This amazing rescue was handled with the utmost composure, compassion, and courage. The personal satisfaction received from such an experience is indescribable. As volunteers we are there when people cry out for help—as human beings we are thankful that we have the ability and the training to help those crying out.
