

Editor's Note:

The following two articles 911 Calls and What to Do On Scene, were written by my two oldest daughters. They are ages 9 and 11. They wrote these on their own with no assistance from me or their daddy. These articles go to show you that our children do pay attention to what we do as rescuers and they understand that what we do is important. Thank you for allowing me to share their articles with the membership.

911 Calls By: Christina Stone – Age 11

Every year thousands of people call 911. Some are serious life and death situations, while others are minor injuries and problems that could be cared for at home. Dispatch centers generally cannot get enough information over the phone to properly triage the calls so it is a first come first serve basis. This can and has caused deaths because sometimes there is a longer response time because the ambulance has to come from further away due to the closest ambulance being on a different, sometimes less severe call. If there was a way they could successfully triage people before they arrived on scene they could minimize this problem.

What To Do On Scene By: Ashley Stone – Age 9

Assess: Is my scene safe? If so put on gloves and proceed to your patients. If not stay in the truck until the police gets there. When the scene is safe proceed to your patients. Assess: How bad is my patient hurt. Do I need an ambulance? Do I need a helicopter? If you need a helicopter or ambulance call for one. Splint your patient if needed. Start an IV if needed. When helicopter needed arrives patient on helicopter and if licensed ride to the hospital. If not stay behind to help. When ambulance needed arrives put patient on stretcher and you can ride to the hospital or stay to help. When done at call, throw gloves away!

Ider Rescue Squad

Alabama is well known as a state of championship teams: football, baseball, gymnastics, and even golf. But do you ever think of your rescue squad as a champion team?

Every single member is an important part of the team. From the coach to the equipment manager and water boy - each player has a role with certain duties and responsibilities. Do you practice every day, even in the off season, or only when the coaches are watching? A ball player can only excel when they give their all every day. The same also holds true for squad members. Members need to practice and train at every opportunity in order to be ready when it's their turn to "take the field." Whether you are into sports or not, it's easy to see the correlation. Practice, train, be a team member, follow orders, and show up when you are expected. Think ahead of what to do to improve the next time. Offer to fill in when other team members cannot be present. Carry the load when others can't. Don't expect the 'cheerleaders' to praise you. In life we are seldom shown appreciation for our tasks, but know that you have changed people's lives.

Just remember, no matter how small you think your role is, the team is not complete without you. Always strive to be your best.

GPSr Trackers By: Luther Peebles

Have you struggled with collecting GPSr track data from your teams? Well, if your team is like ours was, there is no wonder.

You have your team turn in their GPSr's after their assignment and you have a dozen or more laying there on the table. Now you need six or eight different cables to connect them to your computer and oh yes, how many different pieces of software to download the data? And how long will it take to get all this data and get it converted and compiled? By the time all that is done you will have people standing around waiting on what to do next.

For us, the solution came when a SAR team showed to help on a search we had. That's when we learned about GPS Data Loggers. A little device that, once you turn it on, goes about collecting information about the travels of the wearer until you turn it off. The one that we use has two buttons and no display, just a few LEDs to show you its status. No real training required here.

Ok, so to better understand just what the heck I am talking about, let me give you the specifics.

The unit we use is the TSI model 760 Data Logger.

(available from http://www.semsons.com/ig760ingpsda.html) Tell them you heard about it from us and that you were told you would get a discount off the advertised price.

It is smaller than a pack of cigarettes and can be carried around your neck with a lanyard.

Having this little device has been a great tool and well worth the money. Each unit has a ID number that we put on it. We have a log sheet that shows who got what tracker. We provide one for each member of the team that goes out into the field. When they get back, we download the data and look to see that the areas have been covered. If not, we can direct a new team to go in and cover the areas that are missed if needed.

Recently, we had a search for two missing boaters. We put four boats on the water and assigned them each routes to search. After they had returned, here is the data for those

searches shown in Google Earth... Each track has been colored a different color to show the different boats. You

may be able to see a couple of areas that were not searched. After debriefing the teams, those areas were judged as clear due to sound sweeps or because of obstacles in the water that prevented entry.

The information collected from the track files show that all assigned areas were searched and that it took, on average, three hours to do each and that a total of 170 miles was traveled.




Here is an example of a simulated evidence search we did. This is a small area but you can get the idea of how useful they could be.

I guess you could buy handheld GPSr's and do the same thing. That would give you a display and more functionality, but they require that everyone turn on the track log, that the batteries are charged and last long enough and that they are not carried where the satellite signal gets blocked. There is the training that has to be do on a constant basis so everyone is proficient. It just got to be too time consuming for us.

These units have rechargeable batteries, last all day, and recharge in about an hour. Typical accuracy is around 10 feet.

I think they are well worth looking into.
