

### Tallaco K9 Unit, Inc/MR

My words fail me now that I have been asked to write this article for the AARS Rescuer Magazine. So I'd like to start off by telling you a bit about us. Tallaco K9 Unit is a small but dedicated group of men, women and dogs. This type of volunteer work requires a tremendous amount of energy, money and time to train and certify our dogs. Individuals, families and other units ask a lot from our team but no more than we ask of ourselves. We perform the tasks asked of us for our own satisfaction of knowing we can help families in need, not for money or fame.

We currently have four (4) SAR canines we use. Our first dog, our veteran, is Spanky. She's a Border Collie mix that's four (4) years old. She is cross trained to search for HRD and do people tracking and trailing. We also have three (3), three (3) year old sister dogs, Bama, Layla and Zena that are a German Shepard and Belgian Malinois mix. Zena has been cross trained in HRD and tracking and trailing. Bama is currently certified in HRD. Layla is certified in tracking and trailing of people and is working to pass her HRD exam.

Our call outs managed to put us to searching during each season of this year. While the weather didn't always work with us, we made every effort to get the task asked of us accomplished. During February we were called by a broken hearted couple about the loss of their PTSD dog. As a unit, we don't normally respond to these types of requests but as dog lovers and owners a few members felt compelled to help them and volunteered to go on their own. In the awesome month of April, a terrified grandmother asked us to please come search for her runaway grandson in the unfortunate event he had become injured. While July is normally a celebrated month, one family faced a tragedy. So we were asked to come help search for a missing boater in Randolph County. It was a hot and stormy month but when weather permitted we performed land and water searches. Our most current search during August was at the Montgomery Land Fill. Kelly Smith, an employee with INI asked for us to come help for a missing ALDOC inmate. The search proved to be a tough task considering the terrain but our dogs were able to give several alerts to where he had been in the previous days.

In closing I'd like to say thank you to the AARS and to Chauncey Wood for giving us the opportunity to introduce ourselves to you. We hope you have a safe and happy year to come.

### Missing Man Found in Prattville Following Search Marty Roney/Montgomery Advertiser Originally Published August 31,2015 Reprinted with permission.

PRATTVILLE – A four-legged hero is being credited with finding a missing man Sunday morning in Prattville.

The 59-year-old, who has medical problems, wandered off from his home which is near Prattville Junior High School, said Police Chief Mark Thompson. The man was wearing pajamas and had no shoes on.

When police were informed that he was missing the community came together to search, said Thompson. The effort included friends from the man's church, police officers and members of the Prattville Fire Dept. A helicopter from the Alabama Law Enforcement Agency was also involved.

But it was Remi a 2-year-old German Shepherd that saved the day. Fabian and Sherry Mann, members of the Autauga County Rescue Squad, trained Remi.

"The dog was amazing," Thompson said. "We found a footprint near the sidewalk, he put his nose down and then he started tracking. We found the missing man in a wooded area by a creek, several hundred yards from his home."

The family noticed the man missing when they got up about 6 a.m. Sunday, Thompson said. There is no way of knowing how long he had been out of the home when the search began, he said.

Remi did his job "perfectly," Fabian Mann said.

"We're so proud of him," he said. "If you're not a dog handler, you don't know how proud you can be when your dog performs. And this was a long track.

"It was several hours old, people and other animals had been through the area, but Remi led us right to him."

The track covered several hundred yards and crossed through several yards, Mann said.

"When we found him by the creek, it looked like he had just had a seizure," Mann said. "He was kind of out of it. It was very thick where he was. We had to cut a trail in to get to him. We don't know how he was able to get down there. I was glad we were able to find him."

The man was treated by Prattville firemedics on the scene and then was taken home by his family, Thompson said.
