Human Remains Detection (HRD) Searches:
A Hard One for all SAR Teams

"Normal" searches, (if there is any such thing), can be frustrating and have their own problems for the Dog Team handlers and other SAR folks to deal with. HRD Searches, in rough country or in disasters, can be one of the most frustrating and hazardous to the health (both physical and mental) of those who work Search and Rescue.

In HRD cases, search team members may know initially that there will be no "live" find (Drownings, Disasters, Crime Scenes, etc). There are also those searches that result from a citizen finding possible human remains and a Dog Team is brought in to assist in finding more. The idea that we are still returning a person to their loved ones helps, but the simple fact of the matter is that HRD searches can be some of the most difficult and stressful searches a SAR Team member does.

There are those searches that start out as a search for a missing person but ends when the victim is found dead. These can be especially hard on the Teams as the hope is always there for a good outcome to the search. Unfortunately, that is a part of all Search and Rescue operations in general. The actions that must be taken upon the discovery of the missing person change drastically from live to dead. The location of the find becomes a Crime Scene and must be treated as such. The scene must be preserved for Law Enforcement, as death investigations are usually much more complex than a simple "find" of a live person. A more detailed examination of the scene and collection of evidence by Law Enforcement Investigators may be required. When in doubt you should treat any scene as a potential crime scene and try to disturb the site as little as possible. SAR teams should work to protect the scene – not collect evidence.

One of the things that can result from these searches is that dealing with what you see or do can be hard on anyone. Realizing that there can be emotional consequences to you and your teammates from these events is the first step in learning to take care of yourself and each other. This is a part of HRD searches that is usually not covered in training, but it is important. Learning how to deal with these scenes is critical for anyone that does Human Remains Detection work.

First, and foremost is TALK to each other, and realize that you are Not Alone! Some of the things you may be feeling, while they can hard to process, can be a normal part of dealing with these incidents. Everyone can be affected differently but the important thing to remember is that members of a Team are there to help take care of each other and that can be critically important in dealing with these operations.

Critical Incident Stress Debriefing or "CISD": a Process that Helps!

Many professional groups use this process: First Responders; EMTs; Paramedics; Nurses; Fire/Rescue; SAR Team members, etc who are exposed to traumatic events in the course of their work. It has been shown to be a great help in letting them know that everyone responds differently, which is OK and that there are tools and people available to help. THIS IS NOT A JUDGMENTAL PROCEDURE! It is a valuable resource that can help us all.

A "CISD" is small group supportive crisis assistance that helps members of the team support each other. It also lets members know that there are resources that can help. We know that there are times when team members will be involved in events that are hard on them emotionally and that everyone deals with trauma differently. The CISD session is set up under the guidance of a trained counselor and is done as quickly after the actual incident as feasible. Only those members who were involved will be present, with usually one person (Team member not involved in the event) there as a "peer" of the group there to provide background information and support.

The setting is private and should be done in a familiar location. The participants are arranged sitting in a comfortable circle and each person is asked to talk about what role they played in the incident and how this has affected them. A person can pass and not say anything until they have another chance to join in the discussion. As the session progresses, the "sharing" of each experience and the discussion of how the operation went helps each person to see what everyone else was doing and feeling. This is important. Sometimes the overall picture of the operation may not be readily apparent to everyone. It is this information plus input from all the participants that allows each team member to see what part they played in the whole operation, and helps build morale. It can also clear up misunderstandings that sometime occur due to lack of complete information. Having been involved in several CISD sessions in the past has taught me that this can be vital for all involved.

We all know that there are going to be Search and Rescue operations that, despite all the hard work of those involved, will not have a happy ending. When this happens, helping each other work through these times is critical to the wellbeing of all. And, after all, that is what Teamwork is all about.

It's Been Awhile James Miller, ECRS 08/18/2019

Today Etowah County Rescue Squad did, "a man search training exercise" on 84 acres of mostly wooded mountain terrain with creeks, ponds, all the heat you could want & then some. Using four wheelers, gators and just foot soldier walking we worked four hours finding two lost and injured victims. During this simulation we rendered treatment and transported both of them to our holding station. It wasn't done without great amounts of perspiring but it was a needed experience for old members as well as new ones.

Earlier last month, we had some dive training which started because of interest from candidates who had been trained as dive tenders. Then other squads like Guntersville and Blount County Rescue squads' divers wanted to train with us in the Coosa.

So we had classes in pools, classrooms, shallow streams with good visibility to actually diving shallow in our Coosa River. After all this, we now have two new certified divers, plus one other diver advanced himself to the public safety diver status. One of the new divers is in the process of getting his advanced certification.

We have also had members answering the water patrol call outs for us a few times so far. We have asked and are waiting for the water patrol to come teach a water safety / boat license class in our building but he's informed us that the state (Montgomery office) doesn't have books in at this time.

A Big Shout out to our AARS the ECRS who held an Instructor CPR class at our building. I think three Rescue Squads sent two people to this class. We now have three AHA instructors in our squad.

Our divers and members worked with several different entities to aid Guntersville RS with their annual boat race which went off accident free. Great job everyone looks forward to next year's race!

We're doing lots of other training in house and online preparing for the upcoming unexpected.

Our members are mostly new in the search and rescue business but are eager and willing to learn. They are seeing what sacrifice means, to a rescue squad member. Sometimes you miss a lot of family fun times. Sometimes you sacrifice being at birthday parties, a wife or a girlfriend's pre-made plans, ball games, a good night's sleep in a warm dry bed and a meal. You S&R people know what I'm talking about!

Medical transports are a common thing around the ECRS now. For our crews that try doing them it can keep them busy but they sacrifice hours to meet the needs of others and still attend squad meetings and training sessions.

We find time and ways to volunteer even with obligations to our employer.

It's true you can and will do what you want to! No other person makes the decisions. You are the one that comes up with the (reasons or excuses) to meet your obligations to the volunteer rescue squad you asked to be a part of!

Understanding is very important about the definition or meaning that goes to: sacrifices, obligations, & commitment!

Sum it up to... keeping your word!

I am a Search & Rescue Squad Volunteer and Mighty Proud of it!

VOTING RULES

- 1. EACH REPRESENTATIVE MUST SHOW THEIR MEMBERSHIP CARD AND SIGN THE VOTING REGISTRATION FORM INDICATING THEY ARE VOTING FOR THEIR SQUAD.
- 2. AFTER THE REPRESENTATIVE SIGNS REGISTRATION FORM, A BALLOT WILL BE GIVEN TO THEM INDICATING THE NUMBER OF VOTES THEIR SQUAD IS ALLOWED.
- 3. AFTER THE VOTING HAS CLOSED, THE VOTES WIL BE TALLIED FOR EACH CANDIDATE. TO AVOID A RUNOFF, ONE OF THE CANDIDATES MUST RECEIVE A MAJORITY OF THE VOTES (51.1%).
- 4. AFTER THE VOTES HAVE BEEN COUNTED, EACH MEMBER OF THE NOMINATING COMMITTEE MUST CERTIFY THE RESULTS OF THE ELECTION.
- 5. IF A RUNOFF IS NECESSARY, THE EXECUTIVE SECRETARY-TREASURER WILL BE NOTIFIED AS SOON AS POSSIBLE SO AN ANNOUNCEMENT CAN BE MADE THAT A RUNOFF IS NECESSARY.
- 6. THE NOMINATING COMMITTEE WILL THEN HOLD A RUNOFF ELECTION AND CERTIFY THE RESULTS AS SOON AS POSSIBLE. THE CHAIRMAN OF THE NOMINATING COMMITTEE WILL ANNOUNCE THE RESULTS AT THE GENERAL BUSINESS MEETING.

First Aid Contest Rules and Equipment List

Each team will consist of four members including a working captain. A roster of team members must be submitted.

The contest will consist of three parts:

- 1. A written test for alt team members.
- 2. One rescuer CPR Only one person from each team to compete, selected by the team captain.
- 3. A practical test consisting of multiple trauma victims, to include initial patient survey, vital signs, and treatment.

Each team is to furnish their own equipment and supplies. Judges will be selected from AARS membership. Team scores will consist of total scores for all three parts. The sequence in which teams compete will be determined by a drawing at the team meeting. Trophies will be awarded for first, second, and third place.

EXTRICATION CONTEST RULES

- ALL TEAMMEMBERS MUST BE REGISTED FOR THE CONFERENCE.
- UNREGISTERED COMPETITORS WILL RESULT IN DISQUALIFICATION.
- A TEAM MAY CONSIST OF UP TO FIVE MEMBERS.
- THE CAPTAIN MUST MAINTAIN CONTROL.
- THE JUDGES HAVE ABSOLUTE CONTROL OF THE "PITS".
- NO TIMES WILL BE ASSESSED FOR A "FREEZE".
- THE TIMES WILL BE STOPPED AT 20 MINUTES.
- THE TOOLS FOR THE COMPETITION WILL BE FURNISHED. HOWEVER, IF YOU ELECT TO USE YOUR OWN TOOLS; PLEASE INFORM US AT THE CAPTAINS MEETING.
- ORDER OF COMPETITION WILL BE DRAWN FOR BY THE CAPTAINS.
- TEAMS MUST HAVE SUBMITTED ENTRY FORM BY OCTOBER 15TH.
- FIRST THRU THIRD PLACE TROPHIES: WILL BE AWARDED


