

PRESS RELEASE:

Brierfield Fire and Rescue, Inc. recently obtained a new EMS response vehicle that has been purposely outfitted to respond to EMS non-transport calls. This unit also includes \$24,000 in state-of-the-art extrication tools, provided by a grant from Firehouse Subs.

Our old EMS unit has been donated to the **Huntsville Cave Rescue Unit** (HCRU), based in Huntsville, Alabama. HCRU is an entirely volunteer organization specializing in cave, cliff, high-angle and rough terrain search and rescue operations in north Alabama and surrounding states.

Both Brieffield and Huntsville are members of **The Alabama Association of Rescue Squads** (AARS). This association is made up of 111 rescue units with over 3,000 members located throughout the state of Alabama. According to board president, Jimmy Latham, Brieffield's policy is to "pass on" any unneeded vehicles to other organizations thru the **Terry Farrell Firefighter's Fund of Alabama**. The Terry Fund is a firefighter charity established after the World Trade Center attacks on 9-11. Terry Farrell was serving for the FDNY on Rescue 4 when he was killed during these attacks. Brieffield Fire Chief Spruce McRee is the Alabama director for the fund.

LASAR SARSAR Event Submitted by: LASAR

While driving over the Lillian bridge one early Saturday morning, you notice a small plane flying low and erratic in the distance. You slow down and wonder what the pilot is thinking when suddenly the plane seems to disappear into the wooded area toward Blue Angel Recreation Park. Pulling off the road, you call 911 to report what you have seen. This was the real-world scenario for the South Alabama Rescue Search and Recovery (SARSAR) multi-agency drill held Saturday, Feb. 22. Hosted by Lower Alabama Search and Rescue (LASAR), this multiagency drill included participants from the US Coast Guard, US Coast Guard Auxiliary, Civil Air Patrol, Etowah County Search and Rescue, ALEA Marine Police Division, US National Reserve Corps, Lillian Volunteer Fire Department (LVFD), Orange Beach Fire and Rescue, Perdido Beach Fire Department, Florida State Parks Division, Escambia Search and Rescue (ESAR) and civilian volunteers. 911 was informed of a simulated small plane crash with missing and injured passengers about 6:30 a.m. in the Lillian Perdido Bay area. Emergency units from South Alabama and Escambia County, Florida, were requested to respond and began moving to the command and staging area at the Lillian Boat Launch. Six hours and 40 minutes later, all injured passengers and plane debris were located and responding teams were heading back to their home locations. First on scene were LVFD and LASAR based in Lillian. The boat launch was soon filled with emergency vehicles and boats from these units. The first safety and mission briefing was at 8 a.m. Nine units were on site and given search assignments and areas. By 8:45, more than 140 personnel, ranging in LASAR Hosts Drill for Several Agencies One of several boat teams prepare to deploy as part of the LASAR-hosted emergency drill on Feb. 22. from teens to 70s, from various government and state agencies on land and water were searching a 60 square mile area of Perdido Bay south of the Lillian Bridge and shoreline. The search also included two fixed wing aircraft from the Civil Air Patrol and six search and dive operation boats. Lieutenant Commander Trevor Blount of the US Coast Guard was Incident Commander, heading the search effort. "The exercise was created to enhance the interoperability of federal, state, local and volunteer agencies to build out and refine search and rescue capability in the coastal region," Blount said. He indicated the USCG had limited resources and without the assistance of local units like those responding in the drill, it would be more difficult to respond to all emergencies. He also commented at the close of the drill that it was an outstanding effort by all units responding. LASAR Unit Commander Ray Hogans was the Deputy Incident Commander for the exercise. The LASAR command bus acted as the main command and communications center for the drill. LASAR members manned the radios, receiving status updates from search teams every 20 minutes. Three LASAR boats were deployed along with their dive team. LASAR members were also the "injured passengers" for the drill and were secretly put in place before the search teams were deployed. LASAR also supplied food, soft drinks and water for responders. Hogans said, "Drills like this one give us a chance to practice for a major event because it is not if but when something happens and we need to be ready." LVFD Assistant Chief Joe Jones deployed his team of about 18 members to search on the Lillian side of the bay. Their fire suppression and rescue boat #37 searched the bay and their engine and squad units assisted with land searches. Their team also set up a triage and medical tent in case a responder was injured. US National Reserve Corp General Gregory Bone deployed his team of about 15 members to search on land using their command truck to reach the search area. He said USNRC, which has over 10,000 members nationally, normally respond to natural emergencies like hurricanes. This drill scenario gave them an opportunity to train in skills they do not get to use often. Civil Air Patrol Lieutenant Coronel Harvey Yarborough drove from Mississippi to participate. His team of about 10 local members participated in land searches that had them walking through thigh-high mud as they successfully searched for the plane. Yarborough commented it was amazing to get this many agencies working together so well on the first major drill. Anne Marie Ozkosar, public information officer with the LVFD, said their 32 volunteers were excited to coordinate with the other groups and learn from this experience. Orange Beach Fire and Rescue Chief Bruce Nelson led a team of about 10 members. This included their public safety dive team, their dive trailer, police boat and their fireboat. They also brought the mass casualty incident trailer which is a county resource but is housed at their station. Commander O.B. Pettit's Escambia Search and Rescue unit was based on the Pensacola side at Blue Angel Recreation Park. Their group of over 50 members included K-9 teams, search drone, command and communications truck, medical team and 4wheelers. USCG Auxiliary arrived on site with their boat and crew to search to bay and shoreline. John Cornelius, chaplain for the Etowah County Rescue Squad, and two other members drove from Gadsden to assist. Park Manager Kiersten Wilson of the Florida Park Service was also onsite. The park service gave valuable support for the drill, allowing the use of parkland to stage aircraft debris and injured personnel. National Disaster Response Agency Field Operations Supervisor Michael Ziolkowski and Field Operations Diver Tyler Giblin joined one of the LASAR boat crews in the search. They were in Foley training dogs to join their K-9 search teams when they heard about the drill. Being in the area, they said they just couldn't miss a big drill like this one Working in the newspaper business is always a learning experience. You get to meet fantastic people and see and do some things you wouldn't normally get to do. Attending the media briefing as part of LASAR's mock drill day on Feb. 22 was no exception. I had no idea what to expect for an operation of this size, and I can't begin to tell you how impressed and fascinated I was with every aspect of the drill. I learned this was the first time the Lillian-based LASAR unit had ever planned and hosted a multiagency training exercise. I learned what lengths our area agencies and volunteers go to for practice, education and being there when citizens need a hand, no matter the situation. It was overwhelming in some ways to me as an outsider, but I appreciated how well things were coordinated and arranged. I'm sure things may have been different in an actual emergency, but not by much. Practice like this is invaluable to these groups and in turn, it is invaluable to the rest of us. During this briefing and while touring the command center, I was amazed by the organization, professionalism and dedication of every participant I met or observed. Then it occurred to me how much time and planning this event required. Ray Hogans, commander of LASAR, said they began planning about six months ago, keeping only a few key leaders in the loop so the majority of volunteers and participants wouldn't know what to expect. A fuselage was created to make the scenario more realistic and a number of items were placed in or near Perdido Bay for the teams to find and report back on. This kept the command center extremely busy, as teams had to report in every 20 minutes with a situation report or any time they found a potential piece of evidence. Formal updates were written and were available for media, just as in a real disaster. The search site was divided into six sectors and most had two agencies working together in their assigned area. The coordination between water, land, drone and aviation teams provided invaluable training. Even though this was the first time LASAR had planned such a drill, given the scope and number of participants, it is apparent we are in good hands. Space doesn't permit listing everyone who participated, but I am in awe of these incredible volunteers. No matter what agency they are part of, every single person that I met that day demonstrated how they go above and beyond to provide assistance in whatever way they can. We are very fortunate to have these volunteers who willingly share their knowledge and skills, attend more training to improve or learn new procedures and are always on standby whenever a call goes out. If you know any of the LASAR team members or anyone serving as a volunteer for other local first responder groups in this area, give them a big, heartfelt thanks.
